Overall Responsibilities:

Maintain a clean, sanitary, and safe working environment for all staff, students, and visitors by personally performing the following essential responsibilities. This position is responsible for performing general cleaning and upkeep of the School building.

Essential Position Responsibilities:

\sqcup	Sweeps, vacuums, mops, scrubs, waxes and polishes floors using industrial vacuum
	cleaners and scrubbing and buffing machines.
	Use ladders, dusts and washes walls, cleans ceilings and dusts light fixtures.
	Washes windows and door glass.
	Move classroom and Cafeteria furniture to clean areas.
	Sweep and mop classroom floors, empty trash daily
	Clean and disinfect restrooms, refill dispensers as needed.
	Remove stains from walls and floors using chemicals and cleaning solutions.
	Sweep exterior entrances, remove snow or perform other incidental seasonal tasks.
	Secures facilities nightly.
	This position requires frequent movement about the school building and campus to
	complete the essential job responsibilities as outlined above.
	Other duties as the Pastor and/or Facilities Director requires.
