DECREE NOTABLY ALTERING the PARISH BOUNDARIES of Immaculate Conception Dennison

WHEREAS, a parish is defined as "a certain community of the Christian faithful stably constituted in a particular church, whose pastoral care is entrusted to a pastor as its proper pastor under the authority of the diocesan bishop" (Canon 515 §1);

WHEREAS, "as a general rule, a parish is to be territorial, that is, one which includes all the faithful of a certain territory" (Canon 518);

WHEREAS, the parish boundaries of Immaculate Conception are as yet undefined;

WHEREAS, having duly consulted with the pastor of Immaculate Conception whose parish is affected (Canon 50); having heard the Presbyteral Council which was provided with the necessary information, lawfully convoked according to Canons 127 and 166 on 8 January 2025, and offered genuine consultation according to Canon 515 §2 in the form of unanimous agreement with the proposed definition of the boundaries of the parish;

WHEREAS, having determined that the good of souls will suffer no harm and will benefit from a more certain definition of the parish boundaries in question;

THERERFORE, having considered the law and the facts, I, Most Reverend Earl K. Fernandes, Bishop of Columbus, decree the following:

1) That the boundaries of Immaculate Conception Parish, the parish church of which is located at 206 N. First St., Dennison, OH 44621-1296 are the following:

The coordinates of the parish's boundaries are defined by the following latitudinal/longitudinal coordinates and geographic landmarks. Northern boundary: Starting at the Tuscarawas-Carroll counties boundary at 40.47681, -81.26843, west on Union Township's northern boundary to 40.47796, -81.32583; north on the township boundary to 40.48410, -81.32544; west on the township boundary to Union Township's northwestern corner at 40.48450, -81.34441. Eastern boundary: Starting at the Tuscarawas-Carroll counties boundary at 40.47681, -81.26843, south on the county boundary to 40.30343, -81.27531; west on the county boundary to 40.30431, -81.33460; south on the county boundary to the southeastern corner of Tuscarawas County at 40.21425, -81.33805. Southern boundary: Starting at the southeastern corner of Tuscarawas County at 40.21425, -81.33805, west on the county boundary to the Washington-Oxford townships boundary at 40.21902, -81.52802. Western boundary: Starting at the Washington-Oxford townships boundary on Tuscarawas County's southern boundary at 40.21902, -81.52802,

north on the township boundary to 40.28666, -81.52509; east on the township boundary to 40.28637, -81.51950; north on the township boundary to 40.29329, -81.51922; east on the township boundary to the intersection of the Washington-Oxford-Clay townships boundaries at 40.29300, -81.49520; north on the Clay Township boundary to the Tuscarawas River; north on the Tuscarawas River to the intersection of the Tuscarawas River and a western branch of the Tuscarawas River at 40.33959, -81.48432; northwest-north on the western branch of the Tuscarawas River to 40.34727, -81.49126; north on the township boundary to U.S. Route 36; northeast on the center of U.S. Route 36 to State Route 416; northeast-north on the center of State Route 416 to the Warwick-Goshen townships boundary at 40.43568, -81.40643; east on the township boundary to the Warwick-Goshen-Mill townships intersection at 40.43450, -81.37445; east on Mill Township's northern boundary to the Mill-Goshen-Union townships intersection at 40.4383, -81.34650; north on Union Township's western boundary to Union Township's northwestern corner at 40.48450, -81.34441.

- 2) That this alteration shall take effect upon the promulgation of this decree.
- 3) That this decree shall be promulgated by publication on the Diocese of Columbus website and in *The Catholic Times* diocesan newspaper.
