DECREE NOTABLY ALTERING the PARISH BOUNDARIES of Sacred Heart Coshocton

WHEREAS, a parish is defined as "a certain community of the Christian faithful stably constituted in a particular church, whose pastoral care is entrusted to a pastor as its proper pastor under the authority of the diocesan bishop" (Canon 515 §1);

WHEREAS, "as a general rule, a parish is to be territorial, that is, one which includes all the faithful of a certain territory" (Canon 518);

WHEREAS, the parish boundaries of Sacred Heart are as yet undefined;

WHEREAS, having duly consulted with the pastor of Sacred Heart whose parish is affected (Canon 50); having heard the Presbyteral Council which was provided with the necessary information, lawfully convoked according to Canons 127 and 166 on 8 January 2025, and offered genuine consultation according to Canon 515 §2 in the form of unanimous agreement with the proposed definition of the boundaries of the parish;

WHEREAS, having determined that the good of souls will suffer no harm and will benefit from a more certain definition of the parish boundaries in question;

THERERFORE, having considered the law and the facts, I, Most Reverend Earl K. Fernandes, Bishop of Columbus, decree the following:

1) That the boundaries of Sacred Heart Parish, the parish church of which is located at 805 Main St., Coshocton, OH 43812-1694 are the following:

The coordinates of the parish's boundaries are defined by the following latitudinal/longitudinal coordinates and geographic landmarks. Northern boundary: Starting at the northwest corner of Coshocton County at 40.45628, -82.18460, east on the county boundary to 40.45289, -82.08597; north on the county boundary to 40.45410, -82.08588; east on the county boundary to County Route 53; north on the center of County Route 53 to 40.45128, -81.98869; east on the county boundary to 40.44885, -81.89387; south on the county boundary to 40.44810, -81.89390; east on the county boundary to the northeastern corner of Coshocton County at 40.44477, -81.70913. Eastern boundary: Starting at the northeastern corner of Coshocton County at 40.44477, -81.70913, south to 40.37080, -81.71228; east the county boundary to Coal Road; east on the center of Coal Road to 40.37004, -81.68257; east on the county boundary to Coshocton-Tuscarawas counties boundary at 40.36811, -81.61603; east on the Salem Township, Tuscarawas County, boundary line to 40.36773, -81.60075; south on the township boundary to

Little Buckhorn Road at 40.36669, -81.59953; north on the center of Little Buckhorn Road to 40.36780, -81.59918; east on the township boundary to 40.36582, -81.52054; north on the township boundary to 40.36633, -81.52052; east on the township boundary to the northeast corner of Salem Township at 40.36577, -81.49014; south on the township boundary to a western branch of the Tuscarawas River at 40.34727, -81.49126; south on the center of the branch of the Tuscarawas River until it intersects the main course of the Tuscarawas River at 40.33960, -81.48432; south on the center of the Tuscarawas River to 40.32834, -81.49291; south on the township boundary to 40.29301, -81.49519; west on the township boundary to 40.29329, -81.51923; south on the township boundary to 40.28637, -81.51950; west on the township boundary to the Salem-Oxford townships boundary at 40.28666, -81.52509; south on the township boundary to the Tuscarawas-Guernsey counties boundaries at 40.21902, -81.52802. Southern boundary: Starting at boundary to the Tuscarawas-Guernsey counties boundaries at 40,21902, -81.52802, west on the county boundary to the Tuscarawas-Coshocton counties boundary at 40.22130, -81.62268; west on the Coshocton County boundary to 40.22246, -81.66758; south on the county boundary to 40.15097, -81.67090; west on the county boundary to 40.15216, -81.71627; north on the county boundary to 40.15285, -81.71627; west on the county boundary to Schoolhouse Road at 40.16170, -82.08719; west on the center of Schoolhouse Road to 40.16217, -82.09026; west on the county boundary to Mt. Zion Road at 40.16234, -82.09304; north on the center of Mt. Zion Road to 40.16258, -82.09299; west on the county boundary to the southwestern corner of Coshocton County at Church Road at 40.16688, -82.18713. Western boundary: Starting at the southwestern corner of Coshocton County at Church Road at 40.16688, -82.18713, north on the center of Church Road to 40.18277, -82.18679; north on the county boundary to 40.23862, -82.18282; west on the county boundary to 40.23907, -82.19591; north on the county boundary to Wakatomica Road at 40.32995, -82.19125; north on the center of Wakatomica Road to St. Rt. 229, whereupon the road's name changes to Brush Run Road; north on the center of Brush Run Road to 40.34735, -82.19039; north on the county boundary to the northwestern corner of Coshocton County at 40.45628, -82.18460.

- 2) That this alteration shall take effect upon the promulgation of this decree.
- 3) That this decree shall be promulgated by publication on the Diocese of Columbus website and in *The Catholic Times* diocesan newspaper.
