DECREE NOTABLY ALTERING the PARISH BOUNDARIES of St. Bernadette Lancaster

WHEREAS, a parish is defined as "a certain community of the Christian faithful stably constituted in a particular church, whose pastoral care is entrusted to a pastor as its proper pastor under the authority of the diocesan bishop" (Canon 515 §1);

WHEREAS, "as a general rule, a parish is to be territorial, that is, one which includes all the faithful of a certain territory" (Canon 518);

WHEREAS, the parish boundaries of St. Bernadette are as yet undefined;

WHEREAS, having duly consulted with the pastor of St. Bernadette whose parish is affected (Canon 50); having heard the Presbyteral Council which was provided with the necessary information, lawfully convoked according to Canons 127 and 166 on 8 January 2025, and offered genuine consultation according to Canon 515 §2 in the form of unanimous agreement with the proposed definition of the boundaries of the parish;

WHEREAS, having determined that the good of souls will suffer no harm and will benefit from a more certain definition of the parish boundaries in question;

THERERFORE, having considered the law and the facts, I, Most Reverend Earl K. Fernandes, Bishop of Columbus, decree the following:

1) That the boundaries of St. Bernadette Parish, the parish church of which is located at 1343 Wheeling Rd., Lancaster, OH 43130 are the following:

The coordinates of the parish's boundaries are defined by the following latitudinal/longitudinal coordinates and geographic landmarks. Northern boundary: Starting at the intersection of Bickel Church Road NE and Millersport Road, east on the center of Bickel Church Road NE to Lake Road NE; south on the center of Lake Road NE (State Route 62) to Walnut Creek; east on the center of Walnut Creek to the intersection of Walnut Creek and New Salem Road NE at the Fairfield-Perry counties boundary. Eastern boundary: Starting at the intersection of Walnut Creek and New Salem Road NE at the Fairfield-Perry counties boundary, south on the center of New Salem Road NE to Baltimore Somerset Road NE; east on the center of Baltimore Somerset Road NE to 39.83303, -82.39617; south on the county boundary to 39.74460, -82.40424; east on the county boundary to Harvey Road-Avlon Road; east on the center of Harvey Road-Avlon Road to 39.74312, -82.37785; east on the county boundary to 39.74252, -82.36605; south on the county boundary to the southeast corner of Fairfield County at 39.65496, -82.37452. Southern boundary:

Starting at the southeast corner of Fairfield County at 39.65496, -82.37452, west on the county boundary to 39.66170, -82.49032; south on the county boundary to 39.60285, -82.49612; west on the county boundary to 39.60860, -82.61754; south on the county boundary to 39.56398, -82.62009; west on the county boundary to Clearport Road SW (at 39.56693, -82.69414). Western boundary: Starting at the intersection of Bickel Church Road NE and Millersport Road, south on the center of Millersport Road-High Street to State Route 256; west on the center of State Route 256 to Old Millersport Road; south on the center of Old Millersport Road to Coonpath Road NE; west on the center of Coonpath Road NE to the resumption of Old Millersport Road; south on the center of Old Millersport Road, which becomes Sheridan Drive at Malibu Road; south on the center of Sheridan Drive to Rainbow Drive NE; west on the center of Rainbow Drive NE to the resumption of Sheridan Drive; south on the center of Sheridan Drive to the intersection of Sheridan Drive, East 6th Avenue, Pleasantville Road, and North Cherry Street; south on the center of North Cherry Street to U.S. Route 22, where the road becomes South Cherry Street; south on the center of South Cherry Street to its terminus; an air-line straight south to Lawrence Street; east on the center of Lawrence Street to Baldwin Run; south on the center of Baldwin Run to the Hocking River; south on the center of the Hocking River to Logan-Lancaster Road; due west from the intersection of the Hocking River and Logan-Lancaster Road an air-line to Hamburg Road SW; southwest on the center of Hamburg Road SW to Hopewell Church Road SW; south on the center of Hopewell Church Road SW to Clear Creek Road SW; south on the center of Clear Creek Road SW to McDonald Road SW; southwest on the center of McDonald Road SW to Clearport Road SW; south on the center of Clearport Road SW to the Fairfield-Hocking counties boundary at 39.56693, -82.69414.

- 2) That this alteration shall take effect upon the promulgation of this decree.
- 3) That this decree shall be promulgated by publication on the Diocese of Columbus website and in *The Catholic Times* diocesan newspaper.
